## **Giving for the Gospel**

The Bible gives advice on giving financially for the work of the gospel.

#### **Principles of Giving (2 Cor. 8-9)**

- ◆ sacrificially (8:1-2) despite our needs
- ♦ generously (8:3-7) as much as we are able
- gratefully (8:8-9) for the grace of Christ who though rich became poor that we might be rich
- ◆ realistically (8:10-12) according to our means
- equally (8:13-15) our plenty to supply what others need
- ◆ properly (8:16 -24) ensuring that our management of money is above reproach
- ◆ actually (9:1-5) to ensure our practice matches our preaching
- freely (9:6-7) not reluctantly but cheerfully.
- confidently (9:8-11) knowing that God will always supply our needs
- encouragingly (9:12-17) others will praise God for what he is doing in our lives

#### **How to Give**

Paul gives the Corinthians some practical advice on how they should give. He says they should each set aside a sum of money in keeping with their income on the first day of every week. (1 Cor 16:2) This provides us with some useful practical steps:

- We should think about our giving first—not just give what is left at the end of the week.
- Our giving should be regular. If we are paid monthly, we should set aside money monthly. This helps to avoid the trap of thinking we will get around to writing a cheque next month, or next week, but when the time comes finances are tight and we end up giving reluctantly.
- Everyone should be involved. Giving is something we should all want to take part in.

## **Notes for Gift Aid Declaration**

- (1) You can cancel your gift aid declaration at any time by notifying one of the church treasurers or the gift aid secretary.
- (2) You must pay an amount of Income Tax and/or Capital Gains Tax for each tax year (6 April to 5 April) that is at least equal to the amount of tax that *all* the charities or Community Amateur Sports Clubs that you donate to will reclaim (currently 25p for each £1 donated) each tax year. Other taxes such as VAT and Council Tax do not qualify.
- (3) If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
- (4) If you are unsure whether or not your donations qualify for Gift Aid tax relief, ask the church treasurers or your local tax office for leaflet IR113 Gift Aid.
- (5) If you are married and both pay tax, two separate declarations will need to be made if you wish the church to reclaim tax from both of you.
- (6) Please notify the church treasurers or gift aid secretary if you i) change your name or address ii) no longer pay sufficient tax on your income and / or capital gains (viz point 2 above) iii) want to cancel your gift aid declaration.

Gift Aid is a Government scheme whereby charities are able to reclaim tax payable on gifts received (currently 25p for every £1 you give). If you are a taxpayer this makes your gift even more valuable to us at no extra cost to you. To take advantage of this scheme, please fill in the Gift Aid form in this leaflet and return it to the Church Treasurers or Gift Aid Secretary.
